The event will take place in the framework of the **project 619998-EPP-1-2020-1-UA-EPPJMO-MODULE** "European standards for the protection of the rights of consumers of financial services" under the Erasmus + program Jean Monnet.

***The Round Table will cover the following issues:***

1. Legal support for the development of the financial services market in the context of globalization;
2. Current issues of legislation adaptation on the regulation of financial services markets to European standards;
3. Areas of improvement of legal regulation of procedures for supervision of professional participants in financial services markets: European and world standards;
4. Problems of protection of the rights of consumers of financial services and forms of their protection: national and foreign experience.

The name of the file with the abstracts must correspond to the name and surname of the Round Table participant (for example, Petrenko\_Ivan.doc).

**Requirements to the abstracts:**

- ❖ The volume of abstracts - up to 5 pages, font Times New Roman, size 14, line spacing 1.5, all margins - 20 mm.
- ❖ The first line - the name of the section (alignment - on the right-hand side of a page).
- ❖ The second line - the title of the abstract (in capital letters, bold, centered).
- ❖ The third line - surname and initials of the author, academic degree, academic title, position; place of study.
- ❖ References in the text are recommended to write in square brackets - [2, 56], where the first number is the ordinal number in the list of sources used, the second number - the page number.
- ❖ The list of references should be drawn up at the end of the text under the heading "References" (bold, centered). It must be drawn up under current standards of bibliographic description (MLA style is recommended).

The authors of the abstracts are responsible for their content. As the abstract is not subject to further editing, please, review your abstract for typographical and spelling errors and scientific sense.

Abstracts should reflect the results of scientific research of author (authors) on a topical issue; must be an original submission not presented or published elsewhere.

The organizing committee can reject materials that do not meet the requirements of the Round Table and the requirements on their content and layout.

Participation in the Round Table: *full-time, part-time*.

If the quarantine restrictions extend during the Round Table, the event will take place online.
