I. GENERAL INFORMATION

St. Petersburg State University (Faculty of Law) hosts annual international students' conference, organized in discussion panels as well as round tables and master classes by leading Russian and international legal experts. Detailed program will be published on the official site of the conference (<https://islaco.spbu.ru>) and social networks (<https://www.facebook.com/iSLaCo2021>) no later than 1 March 2022.

You may wish to participate as a Speaker making a presentation on a panel or attend the conference without presentation as a listener. Please note that participating as a speaker implies an opportunity to attend other events of the conference (master classes and round tables); additional registration is not required.

We will provide electronic certificates and diplomas confirming participation in the conference iSLaCo'2022. Editorial house of St.Petersburg University will publish selected scientific abstracts according to the results of discussion panels.

Working languages of iSLaCo'2022: Russian, English. Simultaneous translation from Russian and English will be provided at all master-classes and round tables. Due to the unfavorable epidemiological situation the conference will be held online.

II. PARTICIPATION IN DISCUSSION PANELS

1. International Private Law

«Legal support of business in the international trade»

The section will be held in English.

Moderators of the section: Arseniy Salamatov, Anna Zabrotskaya.

In the era of globalization and rapid trade, active participants in international trade enter into numerous contracts with foreign companies. However, they may face a number of obstacles such as conflicts between national and international law, difficulties in determining the appropriate jurisdiction to hear the dispute, imperfect wording and interpretation of the contract, etc. In this case, we invite students to discuss and analyse the following questions: What are the advantages and examples of legal support for participants in international trade? How do political and legal factors affect international business? What do entrepreneurs need to consider in the different political and legal systems of the world before starting their business activities? Students are allowed to analyse any problems within the scope of the section topic.

IMPORTANT DATES

- Opening of registration for participants (further speakers) and scientific abstracts: 10 November 2021.
- Ending of registration and submission period of scientific abstracts: 15 February 2022 (till 23:59, inclusive).
- Publication of the list of participants who have passed the competitive selection: 15 March 2022.

RULES OF SUBMITTING APPLICATIONS FOR PARTICIPATION AS SPEAKERS

1. If you are interested in participation you need to prepare scientific abstracts. Conference abstracts can be co-authored. However, no more than two per one work is admitted.
2. Fill in the relevant registration form on the official site iSLaCo: https://regforms.spbu.ru/ru/?option=com_rsform&view=rsform&formId=1547. In case of creating a presentation with a co-author, the registration form should be filled once indicating that abstracts have been prepared with a co-author.
3. If you have not received a response from the Organizing Committee, you should write to this email address: islaco@spbu.ru
4. The Organizing Committee reserves the right to reject an application in case of inconsistency of abstracts with the design requirements, inconsistency of abstracts with the

following topic of the section or in case of having numerous spelling or punctuation mistakes.

COMPETITIVE SELECTION OF WORKS

Abstracts are subjected to mandatory competitive selection.

The criteria of selection:

- Conformity of abstracts with the topic of the conference and a section;
- Relevance;
- Absence of plagiarism (the abstracts will be checked by the Antiplagiat system, papers with originality rate below 75% are not accepted).

The Organizing Committee reserves the right not to indicate the reasons for refusal to accept abstracts.

DESIGN REQUIREMENTS FOR ABSTRACTS

1. No more than – 5 pages;
2. Font – Times New Roman;
3. Size – 14;
4. Interval – 1,5;
5. Margins – 20 mm (on all sides: top, bottom, left, right);
6. Paragraph indent – 1,25;
7. Alignment justified;
8. Design of footnotes (font) – Times New Roman;
9. Design of footnotes (size) – 10;
10. Page numbering – in the center, footer;
11. Keywords (5-7 words);
12. Example of the name of the document: «Abstracts. Tom Henes».
