Beogradski centar za ljudska prava poziva vas na konferenciju „Borba protiv torture i drugog oblika zlostavljanja u Srbiji“, **25. marta 2022. godine sa početkom u 10 č., preko Zoom platforme.**

Tema Konferencije biće sagledavanje stanja u Srbiji u oblasti zabrane torture i drugih oblika zlostavljanja, naročito iz ugla nalaza i preporuka koje su upućene Srbiji u poslednjim izveštajima međunarodnih tela – Komiteta protiv torture Ujedinjenih nacija, Specijalnog izvestioca za torturu i Evropskog komiteta Saveta Evrope za sprečavanje torture i nečovečnog ili ponižavajućeg postupanja ili kažnjavanja.

Beogradski centar za ljudska prava je poslednjih deset godina kontinuirano aktivan u oblasti zabrane zlostavljanja. Pravnici Centra su – kako pred domaćim tako i pred međunarodnim telima – zastupali više stotina građana koji su bili zlostavljani od strane javnih službenika ili su bili u riziku od mučenja i drugih oblika zlostavljanja u slučaju vraćanja u zemlje porekla ili zemlje iz kojih su došli u Srbiju. U poslednjih deset godina organizovali smo edukacije za lekare, advokate i studente Kriminalističko-policijske akademije o međunarodnim standardima ljudskih prava u oblasti zabrane zlostavljanja, sačinjavali analize o stanju u ovoj oblasti i izveštavali međunarodna nadzorna tela, pripremili veći broj edukativnih materijala za građane lišene slobode o njihovim pravima i javno zagovarali za prava žrtava.

Radni jezici Konferencije su srpski i engleski, uz obezbeđeno simultano prevođenje.

## INVITATION LETTER

Dear Madam / Sir,

The Belgrade Center for Human Rights invites you to the Conference "Fight against torture and other forms of abuse in Serbia", **on 25<sup>th</sup> of March 2022, starting at 10 am, via the Zoom platform.**

The main topic of the Conference will be an overview of the situation in Serbia in the field of prohibition of torture and other forms of ill-treatment, particularly in the light of the findings and recommendations for Serbia in recent reports by international bodies - the United Nations Committee against Torture, the Special Rapporteur on Torture and the Council of Europe's European Committee for the Prevention of Torture and Inhuman or Degrading Treatment or Punishment.

The Belgrade Center for Human Rights has been continuously active in the field of banning abuse for the last ten years. The Center's lawyers - before both domestic and international bodies - represented hundreds of citizens who were abused by public officials or were at risk of torture and other forms of ill-treatment in the case of return to their countries of origin or countries from which they came to Serbia. In the last ten years, we have organized a number of training for doctors, lawyers, and students of the Criminal Police Academy on international human rights standards in the field of prohibition of torture, compiled analyzes of the situation in this area, and reported to international oversight bodies. their rights and publicly advocated for the rights of victims.

The working languages of the Conference are Serbian and English, with simultaneous translation provided.
